'FARMER FOR A DAY' PROGRAM RELEASE for each child and adult that will ride horses or feed animals. (One per person please!)

**WHAT SHOULD I BRING?** Please bring one of these permission forms per person attending including adults and students if you are going to ride or feed. Dress in appropriate "farm" attire (boots or sturdy shoes, jackets, long pants, work gloves, etc.) and for the weather. No sandals, open-toed or open-heeled shoes allowed when in with the animals. Corbett is generally colder than in town and it can be windy. Please bring well-fitted, work gloves and if you are riding, well-fitted, riding or bicycle helmet. We likely can loan these if needed. Due to insurance restrictions, everyone must wear <u>long pants</u>, <u>sturdy shoes and gloves</u> to work with the animals and <u>helmets</u> to ride horses. We do have a refrigerator and microwave available. Please bring your dinner food with you or there are two small café/markets within a few miles.

In order to ride, each person must have a horse riding or bike riding helmet that fits securely, long (to the ankle) pants, boots or tied-on shoes (no open toed or open heeled shoes allowed), well-fitted gloves, and your hair must be pulled back with nothing flopping in front of your eyes. Please pull your hair back if you are riding or feeding. Keep in mind that your helmet must fit over your hair (that is pulled back) if you are riding.

The rules regarding attire are designed to keep you and/or your child safe. Thank you for your understanding and cooperation.

\*\*\* Please contact us and schedule this with us first to be sure that we have the staff availability.

Then bring this permission form with you for your stay or send with the attending adult. Please print it, fill it out, sign it and bring it with you when you join us. You will need this form, one per person, upon arrival if you are riding horses or feeding animals. Please pay on our web site <a href="www.OldMcDonaldsFarm.org">www.OldMcDonaldsFarm.org</a> on the Farmer For A Day Program page in advance of your stay for Add-Ons like the Morning Chores package, Hay Rides, Fire in the Fire Pit, Horse Riding Lessons, etc.

Again, due to insurance restrictions and the inherent risks of horse or animal related activities, adults and children who do not have this signed and completed permission form will not be allowed to participate in the Morning Chores package or Horse Riding Lessons.
